- NO AWARD: Allied Electronic - Had to disqualify this vendor based on the fact that their bid documents were incomplete.

- 1 Upon request, vendors shall furnish and distribute sufficient copies of their current catalog(s) and/or price list(s), for lines awarded, if applicable, to all the members of the MHEC. We encourage you to create a web page exclusive to our membership for MHEC contract pricing.
- 2 All Net prices, Discounts and Markups shall remain firm throughout the term of the contract.
- 3 Promotional prices and volume discount prices may be available at the time of your purchase.
- 4 Catalogues and price lists may be subject to periodic price adjustments, if applicable, but the discounts will remain fixed throughout the term of the contract. Price increases must be justified by the National Wholesale Price Index or by a manufacturer's increase which is beyond the control of the dealer. Such increases must be approved by the Contracts Coordinator of the MHEC before they are sent out to the membership.
- 5 Upon request, vendors will supply individual written quotes based on the terms of their individual contract, i.e., if pricing is based on a discount off list, the quote will show current list, contract discount and net price. If based on a markup over dealer net, it will show dealer net, contract markup and MHEC net price.
- 6 Various types of purchase orders may be issued against the contract, with no dollar limit, by each respective school, at their discretion, for their requirements as they occur. Some schools may use "telephoned orders" and Procurement credit cards instead of hardcopy orders.
- 7 The vendor will ship and bill the material requested on each purchase order directly to the respective school. Substitutions will not be allowed without the consent of the ordering department.
- 8 Vendor agrees to indemnify and hold the MHEC member institutions harmless against any claim, suits or judgments by any purchasers against any member institution arising out of the purchase of the goods furnished. Vendor will replace any defective or incorrectly furnished goods.
- 9 The contract award will be published to all the members of the Consortium. Use of the contract will be left to the discretion of each respective member. The MHEC is a broad based membership of public and private higher education institutions and other agencies. Some may have existing contracts that will remain in effect until they end. Future participation is optional and remains the choice of the member.
- 10 In Massachusetts, in accordance with Chapter 29, Section 29C and State Regulation 815 CMR 4.03, standard payment terms for state institutions are Net 30 Days, with interest assessable only after 45 days. 10A. Note any rules which may apply in other New England states.
- 11 Nondiscrimination of Employment and Affirmative Action: The Contractor shall not discriminate against any qualified employee or applicant for employment because of race, color, national origin, ancestry, age, sex, religion, physical or mental handicap, or sexual orientation. The Contractor agrees to comply with all applicable Federal and State statutes, rules and regulations prohibiting discrimination in employment including but not limited to: Title VII of the Civil Rights Act of 1964; the Age Discrimination in Employment Act of 1967; Section 504 of



the  
Rehabilitation Act of 1973; the Americans with Disabilities Act of 1990; M.G.L. C.151B and  
151C. 11a Federal Law: Note any additions for other New England States.

- 12 Force Majeure: Neither party shall be liable to the other or be deemed to be in breach of this contract for any failure, delay or in rendering performance hereunder arising out of conditions beyond its reasonable control, and without its fault or negligence. Such conditions shall include, but not be limited to acts of God, Government restrictions, acts of terrorism, war, fires, floods, epidemics, quarantine restrictions, strikes and weather of terrorism, war, fires, floods, epidemics, quarantine restrictions, strikes and weather.
- 13 If vendor is performing any labor this applies to you - Wage Rates: Please visit each States' Department of Labor and Development referencing details or Prevailing Wage Rates and how they are to be paid on State Jobs and how payroll records are to be maintained. These rates will hold for the life of the Contract per the AG, Division of Occupational Safety. Note that several of our schools are public and it is the vendor's responsibility to follow the wage rate guidelines if necessary.
